- Out of lead beyond next designated change area (complete failure to change) • Blatant disobedience (kick out, buck) • Holding Saddle Horn

Disqualifications

Off course; knocking over markers; completely missing log; major refusal (back more than 2 strides); major disobedience; failure to start lope prior to end cone; pattern 1; 4 simple lead changes; in patterns 2, 3, 4, 5 and Green patterns 1, 2, 3; failure to start lope within 30 ft of designated area
